A school may apply for membership in the SFCFL in the fall of each school year. Any school, public or private, residing in Miami-Dade County or Broward County in the state of Florida may become a member school. **The head coach of the school must complete the membership application (attached) and send it with the membership dues by Saturday October 21, 2017 (first SFCFL tournament of the season).**

The annual membership dues are:

\$85.00 for high schools

\$40.00 for junior/middle schools/9th grade supplement*

***[Schools with supplement entries will only be allowed to enter an additional 3 entries of 9th grade only students in each event if the tournament is not full.]**

After October 21, 2017 schools may apply with an additional late fee of \$50.00. Late memberships may be submitted until November 11, 2017. After November 11, NO new memberships will be available.

Member schools are eligible for any/all of the preliminary SFCFL tournaments. In order to compete in the Grand Final Tournament and qualify for nationals, a student must compete **in one of the preliminary tournaments during that school year**. See the calendar (attached) for the current SFCFL tournaments.
